ATHLETIC SUBSTANCE ABUSE ACKNOWLEDGEMENT

As a student athlete, I understand that participation on an interscholastic team is a privilege and a commitment. I have read the expectations for athletes in the Enfield Public Schools Student Handbook.

As a member of a team, I am dedicated to keeping myself in the best physical condition I can in order to perform to the best of my ability and to contribute to the success of the team. As such, training rules are as follows:

1. NO possession and/or use of tobacco products.
2. NO possession and/or use of alcohol.
3. NO possession, sale and/or use of illegal drugs.

“A student will be in violation of this policy if on a school bus, school grounds, during a school session, or anywhere at a school-sponsored activity, or at a school bus stop, he or she is under the influence of alcohol, drugs, steroids or mood altering substances or possesses, uses, dispenses, sells or aids in the procurement of altering substances or over-the-counter drugs or drug paraphernalia. (Students may also be subject to discipline for the conduct listed above when such conduct occurs outside of school activities and off school property.)

Such student shall be subject to discipline and intervention pursuant to the provisions and procedures outlined in the administrative regulation, resulting in removal from all athletics for up to 180 school days.”

I HEREBY AGREE TO ABIDE BY THE POLICIES AND RULES FOR THE MEMBERS OF THE ENFIELD PUBLIC SCHOOLS ATHLETIC TEAMS: I UNDERSTAND THAT VIOLATION OF SUCH RULES, INCLUDING BUT NOT LIMITED TO THE RULES SET OUT ABOVE, MAY LEAD TO MY REMOVAL FROM THE TEAM FOR UP TO 180 SCHOOL DAYS.
